St. Lawrence Lodge to Undertake Exterior Surface Remediation Work Starting Late April/Early May 2015.

The Home's exterior surface is known as an Exterior Insulation Finish System or EIFS for short. Recently, a contractor noticed that there was a problem with the surface material in some locations. The Home checked with a building envelope expert who confirmed that the Lodge exterior does have some areas that will require attention, sooner rather than later. Consequently, the Board has decided to hire a company called Dominion Caulking Limited to do the corrective work.

At this time, it looks like Dominion will begin their work in late April or early May. The work is dependent on good weather and they expect that they will be on-site for a number of weeks.

There are three phases to the work. First, they will clean the EIFS exterior of the building and courtyards, using high-pressure washers and scrubbing of the surface. Second, they will be removing the existing sealant material and re-installing sealant at the joints in the EIFS structure. Third, they will be conducting EIFS repairs and concrete repairs where needed.

The Home will be meeting with the contractor shortly to firm up the work schedule and to determine what implications the work will have on access to resident outdoor amenity spaces, such as balconies and courtyards. There is expected to be some interference at times, but we do not know the extent at this time. We will be posting information for residents, families, and visitors, once we know how the work will proceed in each area of the building.

Arrangements can be made in advance to have your belongings labeled before use.

Please bring your items into the Home early so they can be labeled and ready for wear and use. Thank you for your cooperation.

- Alcohol-based hand rub is really effective for cleaning your hands. Get in the habit of using it several times a day.

Wheel Chair Program Update

St. Lawrence Lodge has a limited number of wheelchairs which can be lent to residents for a short period of time. They are not intended for use on a permanent basis. Residents that need a wheelchair for mobility will need to make arrangements to acquire the necessary mobility equipment.

Over the next 6 months, residents/families will be contacted with details on how they can purchase a wheelchair through the Assistive Device Program (ADP) of Ontario.

To be eligible for ADP funding, an individual must be assessed by an authorized ADP assessor. St. Lawrence Lodge uses Christine Rostek, a registered Occupational Therapist.

Occupational Therapy Referrals for Mobility Devices

Christine Rostek is a registered Occupational Therapist with over 20 years experience in seating and mobility and has worked in various settings including rehabilitation, long term care and community care. She is an Assistive Devices Authorizer for mobility devices.

The Assistive Devices Program (ADP) is a government-funded program, which will contribute up to 75 % of the cost of a mobility device that is required for ongoing daily mobility. In order to receive assistance from the ADP program for a wheelchair or walker an Occupational Therapist or Physiotherapist who is registered as an authorizer with ADP will assess eligibility for the program, functional mobility status and recommend the appropriate device to best meet individual needs.

ADP does not pay assessment fees for the services of the authorizer. The consumer of Occupational Therapy services is required to pay the assessment fee. The Occupational Therapist is obligated to communicate to the consumer the scope and costs of any services they propose to provide so that financial obligations are understood from the onset. Services delivered by a registered Occupational Therapist are recognized as a deductible medical expense for income tax purposes.

Other funding sources that may be available include Veteran Affairs Canada, Social Assistance Benefits under Ontario Works, Ontario Disability Support Program, and Insurance Coverage for the payment of the remaining 25% towards the cost of the mobility device.

Fees for OT services by Christine Rostek are listed below:

Walkers \$85.00
Manual Wheelchairs \$200.00
Power Wheelchairs \$250.00
Scooters \$200.00
Seating (cushion/backrest) \$60.00/hour
Power Tilt Wheelchairs \$350.00

Once a referral is received the fee outlined above includes an initial interview, physical, and functional assessment, trial of the mobility device, follow-up and modification of the prescribed equipment as required, completion and submission of the Assistive Devices Program application form to the Ministry of Health and Long Term Care.
